Subject: Clarification in respect of mismatch between PTG and ST names during verification and correction phase of SECC-Regarding

Madam/Sir,

In the verification and correction module of the SECC, all the households where the Caste/Tribe name returned by a person is not from PTG and the return with respect to PTG is 'Yes', the households have been selected for verification.

A clarification in this regard has been sought by the Andhra Pradesh Government, where a PTG "Konda Savara" is not exactly found in the ST list. As a result, this is giving a mismatch and the State wishes to know what ST name should be recorded for this.

In this regard, it is to intimate that in such cases, the parent tribe name should be recorded as ST name.

The following ST names may be selected from the drop down menu of the ST in such cases. The ST names to be selected for the specific PTG name is as under:
