G.S.R. 322.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the office of the Registrar General, India and the offices of the Directors of Census Operations in States and Union Territories, Assistant Compiler, Group 'C' Post Recruitment Rules, 2005, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Compiler in the Office of the Registrar General, India and the Offices of the Directors of Census Operations in States and Union Territories, namely:—

1. Short title and commencement.—(1) These rules may be called the Office of the Registrar General, India and the Offices of the Directors of Census Operations in States and Union Territories, Assistant Compiler, Recruitment Rules, 2011.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, Classification and pay band and grade pay or pay scale.—The number of post, its classification and the pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit, educational qualifications, etc.—The method of recruitment, age limit, educational qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification.—No person, —

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
