- (ii) 3 (three) copies of Layout Map (A-3)size (75 gsm)-28100 copies approx.
- (iii) 2 (two) copies of Charge Register (A-3)size (75 gsm)-62000 copies approx.

TERMS AND CONDITIONS :-

1. Final and net rates for the supply of above Item in question shall have to be quoted inclusive of all taxes.
2. The rate tendered should be inclusive of cost of the delivery at O/o the Directorate of Census Operation, Uttarakhand,274, Phase-1 Vasant Vihar, Dehradun.
3. No advance payment will be made until the materials are received in good condition and as per specification and requirement.
4. The above items shall have to be supplied within 15 (fifteen) days from the date of supply order issued by this office.

5. The tender received will be opened at 16:00hrs.on the same day if possible, in presence of the bidders or their representatives.
6. If the items are not supplied per specifications given above, the same will be rejected by the tender inviting officer and same will have to be replaced by the supplier from his own cost & risk.
7. The tenderer will have to produce sample copy of the paper along with tender.

The lowest bidder will collect charge wise of the above documents as per schedule given by the DCO, Uttarakhand and the same will be returned back to this office after completion of the photocopying work within stipulated time in case the photocopying work is done at the location decided by the tenderer.
