## Terms & Conditions

1. The records contains Scrap Materials etc., weighing about 5 M.T. (approximate). The successful tender will have to lift such records on "As is where is basis" without detaching the above. This record is to be pulped in the paper mills in the presence of the representative of this Directorate
2. In the event of failure to lift the material by the successful tenderer at the rates once accepted during the period of contract i.e. within one month from the date of awarding the job. the Security deposit of Rs. 5,000/- (Five Thousand) shall be forfeited and contract terminated.
3. The rate should be quoted per quintal. The rates quoted would be exclusive of transportation, loading, unloading, weighing, etc., the expenditure on which will be borne by the tenderer.
4. The rates accepted will be valid for a period of one month from the date of conveying the approval of the rates by this Directorate. The successful tenderer will have to deposit an amount of Rs. 5,000/- (Five Thousand) as security deposit by way of a Demand Draft to be drawn in favour of the Director of Census Operations, Maharashtra, Mumbai, on acceptance of the rate.
5. The material will be lifted after making full payment to the authorized representative of this Directorate. The record will be got weighed on "Electronic Weigh" in the presence of authorized representative of this Directorate
6. The contractor should furnish the PAN numbers on the bills.
7. Time Response: All the material is to be disposed without fail within a minimum period of 7 days from the date of issue of order.
8. A penalty of 1.5% on the total amount of each order shall be imposed for each week delay after stipulated period subject to a maximum of 9% in case the delay exceeds four weeks, for disposing material, the contract will be terminated and security deposit will be forfeited.
9. **Performance Security:** The successful Bidder awarded with the job shall be required to deposit Performance Security equivalent to 10% of the total value of the order rounded up to next thousand within seven days from the date of receipt of order, in the form of Account Payee Demand Draft/Pay Order/Banker's Cheque /Bank Guarantee from a Nationalized/Scheduled Commercial Bank in favour of "**The Director of Census Operations, Maharashtra Mumbai**" payable at Mumbai. On request of the Bidder, the Earnest Money Deposit (EMD) will be adjusted against the Security Deposit payable by the bidder and bidder shall deposit the balance amount in the prescribed mode and specified time limit. If the Security Deposit is not paid within time specified, the Earnest Money Deposit of the bidder shall be forfeited. In such case, DCO Maharashtra shall be entitled to get the work executed from elsewhere and recover the consequential loss sustained from the bidder due to getting the work executed either through some other bidder or through the bidder selected through the process of re-tendering. **The "Performance Security", shall be released by DCO Maharashtra after the successful completion of disposal of material with satisfaction of the DCO Maharashtra.** No interest will be payable for "Performance Security". In the event of non-providing the services, the Performance Security shall be forfeited to the extent that the materials have not been supplied in conformity to the specified specification and to the satisfaction of the DCO Maharashtra. Further, if the DCO Maharashtra has to get the materials from any other Bidder because of failure to provide in full or part by the successful Bidder, the difference in payment may be made from such amount.
